

**End User License Agreement for UnicorMed Alpha II CodeWizard  
(the "UnicorMed Terms and Conditions")**

("UnicorMed") hereby grants to Allscripts client ("Client") utilizing the Allscripts Software a non-transferable and non-exclusive restricted license to use UnicorMed's Alpha II CodeWizard Software as only integrated with the Allscripts Software, and, and in accordance with these UnicorMed Terms and Conditions and the Agreement between Allscripts and Client. Upon termination of these UnicorMed Terms and Conditions all licenses and rights to Alpha II Code Wizard, or any functions or components thereof, granted to Client terminate. All written materials related to the Alpha II CodeWizard are copyrighted by UnicorMed, and may not be reproduced in any fashion without the express written permission of UnicorMed. Contained within the Alpha II CodeWizard is certain proprietary information owned by (and which constitutes a trade secret of) UnicorMed, including, but not limited to, information that links various medical procedures to certain insurance claims and/or insurance codes ("Proprietary Information"). Client agrees not to disclose, or allow the disclosure of, the Proprietary Information to third parties.
